5 FAH-3 H-300, ORGANIZATIONS; 5 FAH-3 H-400, GEO-POLITICAL TAGS; AND 5 FAH-3 H-500, PROGRAM TAGS ("K" TAGS)

CHANGES

1. Chapters H-300, H-400, and H-500 are revised/updated. While material within each chapter has been updated, specific revisions are as follows:

- **Chapter H-300**—the addition of the new organization acronym FSCADP. This is to be used for FSC Paris ADP Center.
- **Chapter H-400**—the addition of the new Geo-Political TAGS East Timor (TT).
- **Chapter H-500**—the addition of new Program (K) TAGS KCOM, KGIT, KHLS, KLBO, KMPI, KMRS, KPDC, and KTFN. Program (K) TAGS KGCC, KBNC, KJRE, and KOFO are deleted.

2. Revisions since the last update appear in italics. The italics will be removed the next time the material is updated. Only current changes will appear in italics. Italics provide a historical record of changes.

3. Officers are reminded that Department-issued materials not codified in the *Foreign Affairs Manual* or its supplemental *Foreign Affairs Handbook* series generally have no regulatory validity (see 2 FAM 1115.2).

FILING INSTRUCTIONS

1. Remove 5 FAH-3 H-300, H-400, and H-500 and insert the revised identically numbered chapters in their respective places.
2. After inserting the materials in the handbook, insert this transmittal letter immediately following the TL Checklist, then fill in the entry line for TL:TAGS-20, and initial.
