WE ANTICIPATE THAT PARTNERS NATIONS WOULD EACH RECEIVE AN INDIVIDUAL BRIEFING. AS ALLIES WILL NOTE, THIS DRAFT DERIVES FROM THE PRESENTATION THE U.S. MADE DURING THE NOVEMBER "BRAINSTORMING" SESSION BUT HAS BEEN MODIFIED TO ACCOUNT FOR THE DIFFERENT AUDIENCE.

ULTIMATELY, CURRENT ALLIES WILL DECIDE BY CONSENSUS WHETHER TO ACCEPT EACH NEW MEMBER ACCORDING TO THEIR JUDGMENT OF WHETHER DOING SO WILL CONTRIBUTE TO SECURITY AND STABILITY.

NEW MEMBERS WILL, HOWEVER, NEED TO CONFORM TO CERTAIN BASIC PRECEPTS AS EMBODIED IN THE PREAMBLE OF THE WASHINGTON TREATY: DEMOCRACY, INDIVIDUAL LIBERTY AND THE RULE OF LAW.

- F. I. THE PARTNERSHIP FOR PEACE PROVIDES THE FRAMEWORK BY WHICH NATO WILL EVOLVE AND EXPAND. PFP WILL REMAIN IMPORTANT IN ITS OWN RIGHT AS A FIXTURE IN THE EUROPEAN SECURITY STRUCTURE.
