2. DEPARTMENT CONSIDERING ISSUANCE OF TRAVEL ADVISORY FOR CHILE GIVEN RECENT TERRORIST ACTIVITIES AND GOVERNMENT DECISION TO IMPOSE VEHICULAR CURFEW. SIMILAR ADVISORIES HAVE BEEN ISSUED FOR SEVERAL COUNTRIES INCLUDING COLOMBIA, BANGLADESH, KUWAIT AND INDIA. PROPOSED TEXT CONTAINED PARA THREE. WE WOULD APPRECIATE EMBASSY COMMENT/REACTION TO PROPOSAL.

3. BEGIN TEXT:

THE DEPARTMENT OF STATE ADVISES U.S. CITIZENS CONSIDERING TRAVELLING TO CHILE THAT DUE TO AN INCREASE IN TERRORIST BOMBINGS AND SECURITY DISTURBANCES, THE GOVERNMENT OF CHILE HAS IMPOSED A CURFEW ON VEHICULAR TRAFFIC FROM 0200 HOURS TO 0500 HOURS IN THE SANTIAGO METROPOLITAN REGION AND THE PROVINCE OF SAN ANTONIO. AMERICANS PLANNING TO TRAVEL TO CHILE SHOULD VERIFY THEIR FLIGHTS AND GROUND
