THE INISTRY SAID IT HAD RECEIVED NOTHING FURTHER FROM THE RABINEROS SINCE JUNE, BUT PROMISED THAT IF IT DID E INFORMATION WOULD BE PROMPTLY COMMUNICATED TO THE !BASSY. THE NOTE ALSO POINTED OUT THAT A JUDICIAL IVESTIGATION BY THE SECOND CRIMINAL COURT OF SAN CARLOS D BEEN OPENED INTO THE WEISFEILER DISAPPEARANCE IN NUARY, AND SUGGESTED THAT ANY NEW REQUESTS FOR VESTIGATION "AND OTHER POSSIBLE JUDICIAL STEPS THAT GHT BE DEEMED APPROPRIATE" SHOULD BE CHANNELED ROUGH THE COURT. 
