2. SUMMARY: EMBASSY HAS BEEN TOLD BY A MAN CLAIMING TO BE A [ ] OF THE CHILEAN ARMY THAT PENN STATE UNIVERSITY MATHEMATICS PROFESSOR BORIS WEISFEILER WAS ALIVE AND BEING HELD IN THE GERMAN IMMIGRANT SETTLEMENT CALLED COLONIA DIGNIDAD AS RECENTLY AS EARLY JUNE, 1987. THE SOURCE, WHO HAS SO FAR REFUSED TO GIVE HIS NAME, CLAIMS TO HAVE BEEN A MEMBER OF AN ARMY PATROL WHICH ARRESTED WEISFEILER AND DELIVERED HIM TO THE COLONIA, WHICH CONSIDERED HIM A QUOTE JEWISH SPY UNQUOTE. SOURCE LATER SAW WEISFEILER ONCE INSIDE THE COLONIA, AND PRIOR TO HIS PATROL'S WITHDRAWAL FROM THE AREA WAS [ ] MEMBER OF THE COLONIA'S GUARD THAT WEISFEILER WAS BEING TORTURED. THE [ ] WAS RECENTLY TOLD BY A MEMBER OF HIS PREVIOUS PATROL WHO IS ONCE AGAIN

PATROLLING NEAR THE COLONIA THAT HE HAD SEEN WEISFEILER IN THE COLONIA IN EARLY JUNE OF THIS YEAR. THE SOURCE SAID THAT THIS INFORMATION SPURRED HIM TO CONTACT HUMAN RIGHTS ORGANIZATIONS, WHO PUT HIM IN TOUCH WITH THE EMBASSY. SOURCE INDICATES THAT WEISFEILER WAS DELIVERED TO COLONIA IN ACCORDANCE WITH STANDING

ORDERS FROM THE HIGH COMMAND OF THE CHILEAN ARMY, WHICH PROTECTS THE COLONIA AND, ALONG WITH THE NATIONAL INFORMATION CENTER (CNI), USES IT AS A TRAINING CENTER. CHILEAN CARABINEROS (POLICE FORCE), WHO HAVE REPEATEDLY DENIED TO EMBOFFS ANY KNOWLEDGE OF WEISFEILER'S WHEREABOUTS, WERE ALLEGEDLY AWARE OF HIS ARREST BY AN ARMY PATROL AND DELIVERY TO THE COLONIA. THE SOURCE MET WITH EMBOFFS ON JULY 2 AND PROMISED TO PHONE US A WEEK LATER; HE HAS NOT DONE SO AND MAY HAVE DECIDED TO BREAK OFF CONTACT. BY SEPTTEL, WE ARE REQUESTING EMBASSY BONN TO DISCUSS THE CASE WITH AMNESTY INTERNATIONAL WHICH IS BEING SUED BY THE COLONIA. END SUMMARY.

3. THE SOURCE: SOURCE STATED THAT HE IS [REDACTED] IN THE CHILEAN ARMY, CURRENTLY ASSIGNED TO [REDACTED]

AND MODERATELY WELL EDUCATED. [REDACTED] AND WAS STATIONED AT THE END OF 1983 IN AN ARMY UNIT SOMEWHERE SOUTH OF SANTIAGO. SOURCE REFUSED TO PROVIDE US WITH HIS NAME OR DETAILS ON HIS POSTINGS, STATING THAT IT WOULD JEOPARDIZE HIS AND OTHERS' SECURITY. HE FORMED PART OF A SEVEN-PERSON PATROL, DRAWN FROM SEVERAL DIFFERENT UNITS, WHICH WAS GUARDING THE NORTHEAST PORTION OF THE PERIMETER OF THE GERMAN PERFECTIONIST RELIGIOUS COLONY COLONIA

DIGNIDAD. (COMMENT: THE AREA IN QUESTION LIES BETWEEN 71.00 AND 71.45 DEGREES WEST LONGITUDE AND BETWEEN 36.15 AND 36.45 DEGREES SOUTH LATITUDE. END COMMENT) HIS OWN AND OTHER PATROLS IN THE AREA WERE UNDER STANDING ORDERS FROM THE VICE-COMMANDER OF THE CHILEAN ARMY TO ARREST ANY STRANGERS FOUND IN THE AREA AND TO DELIVER THEM TO THE COLONIA, AS WELL AS TO FACILITATE THE GOINGS AND COMINGS OF COLONIA PERSONNEL. THE ONLY REASON HE WAS OFFERED FOR THESE UNUSUAL POLICIES WAS THAT THE COLONIA WAS "A GOOD ALLY."

4. MOTIVATION: SOURCE CLAIMED THAT THE KNOWLEDGE THAT WEISFEILER WAS BEING HELD PRISONER TROUBLED HIM AS A CATHOLIC, WEIGHING ON HIS CONSCIENCE, AND THAT HE WAS PROVIDING THE INFORMATION IN HOPES OF SAVING THE LIFE OF THIS AND PERHAPS OTHER PRISONERS. (COMMENT: THE SOURCE NEVER NAMED THE PERSON HE HELPED ARREST AS BORIS WEISFEILER. DETAILS HE PROVIDED MATCH DR. WEISFEILER SO WELL, HOWEVER, THAT THERE APPEARS TO

BE VIRTUALLY NO POSSIBILITY THAT IT COULD BE SOME UNKNOWN THIRD PERSON. END COMMENT.) HE SAID HE DEBATED FOR SOME TIME WHETHER TO APPROACH THE US EMBASSY DIRECTLY, OR THE ISRAELI EMBASSY, BEING UNCERTAIN OF THE PRISONER'S NATIONALITY, OR THE VICARIA DE LA SOLIDARIDAD, EVENTUALLY OPTING FOR THE LATTER. THE VICARIATE OF SOLIDARITY IS THE HUMAN RIGHTS ORGANIZATION OF THE CHILEAN CATHOLIC CHURCH AND ITS OFFICIALS HAVE CONFIRMED SOURCE'S APPROACH TO THEM.

SOURCE GREW INCREASINGLY NERVOUS AND SKITTISH. HE HAD INSISTED THAT EACH MEETING TAKE PLACE IN [ ] OFFICE, BUT [ ] SAID FUTURE MEETINGS WOULD HAVE TO BE AT SOME OTHER SITE IN ORDER TO SHIELD HIS WORK WITH [ ] THE SOURCE WOULD NOT EXPLICITLY AGREE TO A FOURTH MEETING AT ANOTHER

SITE, BUT AGREED TO CONTACT EMBOFFS BY TELEPHONE IN A PRE-ARRANGED MANNER. HE FAILED TO DO SO, HOWEVER, AND TO DATE HAS MADE NO FURTHER CONTACT WITH EITHER EMBASSY OR [ ]

6. WEISFEILER'S ARREST: SOURCE TOLD US THAT THE CHILEAN ARMY HAS REGULARLY PROVIDED PERIMETER PATROLS FOR COLONIA DIGNIDAD. WHAT THE SOURCE TERMED THE "EXTERIOR PERIMETER" OF THE COLONIA APPEARS TO BE A ONE-KILOMETER DEEP ZONE OUTSIDE THE PROPERTY LINE, WHICH ZONE THE ARMY PATROLS. THESE PATROLS ARE APPARENTLY LIMITED TO THE MOUNTAINOUS EAST SIDE OF THE COLONIA, WHILE THE VALLEY SIDE IS SECURED BY A WIRE FENCE. ACCORDING TO THE SOURCE, THE EAST EXTERIOR PERIMETER NOW VIRTUALLY COINCIDES WITH THE UPPER REACHES OF THE LOS SAUCES RIVER, WHILE THE SOUTH PERIMETER RUNS THREE TO FIVE KILOMETERS TO THE NORTH OF THE NUBLE RIVER, ROUGHLY PARALLELING IT. HE STATED THAT THE MAIN ENTRANCE OF THE COLONIA IS ON THE WEST SIDE, ABOUT FIVE KILOMETERS NW OF THE VILLAGE OF SAN FABIAN DE ALICO, CLOSE TO WHERE THE LAND BEGINS TO RISE AWAY FROM THE NUBLE RIVER VALLEY.

7. AT THE BEGINNING OF DECEMBER, 1984, SOURCE WAS POSTED TO A PATROL GUARDING A SECTION OF THE NORTHEAST PERIMETER OF THE COLONIA, ON THE CORDILLERA SIDE OF THE LOS SAUCES RIVER. THIS AREA IS NORTH OF THE CABLE WAY CROSSING THAT RIVER, AS WELL AS NORTH OF THE CONFLUENCE OF THE LOS SAUCES AND NUBLE WHERE THE OFFICAL ACCOUNT HOLDS THAT WEISFEILER PROBABLY DROWNED. EACH PATROL MEMBER USED A FALSE NAME AND WAS INSTRUCTED NOT TO TELL HIS REAL NAME TO HIS PATROL MATES. THE PATROL'S COMMANDER TOLD OUR SOURCE THAT ARMY PATROLS IN

DECEMBER 1984 IN EXPECTATION OF AN IMPORTANT VISITOR TO THE COLONIA ARRIVING FROM BRAZIL VIA PARAGUAY, AND WHO WENT BY THE NAME OF MR. SMITH. (COMMENT: EMBASSY HAD PREVIOUSLY BEEN TOLD BY ANOTHER SOURCE THAT THERE WAS A PARTICULARLY HEAVY MILITARY PRESENCE IN THE AREA IN DECEMBER 1984 AND JANUARY 1985. END COMMENT.) SMITH WAS SUPPOSEDLY TO MEET A CHILEAN BUSINESSMAN AT THE COLONIA WHO WAS ARRIVING FROM THE SOUTH AND WHO WENT BY THE NAME OF RAUSS OR RAUT (PHONETIC). (COMMENT: THE NAZI WAR CRIMINAL WALTER RAUFF IS KNOWN TO HAVE LIVED IN SANTIAGO. HE SUPPOSEDLY DIED SOMETIME IN 1984 BUT NO BODY WAS EXHIBITED AT THE FUNERAL. HIS SON, BY THE SAME NAME, IS THE PRESIDENT OF A CHILEAN MARITIME BROKERAGE FIRM AND IS REPORTEDLY ACTIVE IN RIGHT-WING POLITICAL ACTIVITIES. WE HAVE NO WAY OF KNOWING IF THERE IS ANY CONNECTION BETWEEN THE RAUFF FAMILY AND THE VISIT OF THE MYSTERIOUS MR. SMITH. END COMMENT.

8. IN THE FIRST HALF OF JANUARY 1985, SOURCE'S PATROL RECEIVED A RADIO CALL FROM TWO ARMY TROOPERS GUARDING TH CABLEWAY THAT THEY HAD TURNED AWAY AN INDIVIDUAL TRYING TO MAKE USE OF IT TO CROSS THE LOS SAUCES TO THE NORTH BANK OF THE NUBLE RIVER. (COMMENT: IN THE FIRST TWO SESSIONS, THE [ ] STATED THAT HE WAS UNABLE TO REMEMBER THE DATE IN 1985 WHEN THESE EVENTS OCCURRED. I THE DIRECT INTERVIEW BY EMBOFFS HE PROVIDED THE DATES USED HEREIN. ACCORDING TO PREVIOUS ACCOUNTS OF AREA RESIDENTS, WEISFEILER WAS LAST SEEN ON JANUARY 4, 1985. END COMMENT.) THE ARMY PATROL, WHICH WAS UNDER STANDING ORDERS TO ARREST ANYONE FOUND IN THE AREA, THEN MOVED

SOUTH ALONG THE LOS SAUCES RIVER AND FOUND WEISFEILER ON THE CORDILLERA SIDE, A BIT SOUTH OF ITS CONFLUENCE WITH THE LOS SAUCES. THE SOURCE STATES THAT THE PERSON WAS 1.75-1.8 METERS TALL, ATHLETIC AND MUSCULAR, WITH QUOTE CASTANO OSCURO UNQUOTE HAIR. (COMMENT: WHILE CASTANO OSCURO LITERALLY MEANS DARK BROWN, CHILEANS INVARIABLY DESCRIBE BLACK HAIR, WHICH WEISFEILER HAD, IN THESE TERMS. END COMMENT.)

WEISFEILER HAD HIS BACKPACK ON HIS RIGHT SIDE, ALONG WITH A CANTEEN, WAS WEARING A PARKA, A CHERRY COLORED SWEATER, TAN COLORED THICK WOOL PANTS AND MOUNTAIN BOOTS AND WAS APPARENTLY WASHING SOMETHING IN THE RIVER. THE PATROL APPROACHED WEISFEILER AND ASKED HIM FOR HIS PERMIT TO ENTER THE AREA, WHICH HE SHOULD HAVE OBTAINED FROM THE CARABINEROS AT THE NEARBY EL ROBLE OUTPOST. WEISFEILER COULD PRODUCE NO SUCH PERMIT, AND SO WAS ARRESTED. THE PRISONER SPOKE POOR SPANISH AND APPARENTLY OFFERED NO RESISTANCE. THE PATROL THREATENED WEISFEILER WITH THEIR WEAPONS, MADE HIM KNEEL DOWN WITH HIS HANDS BEHIND HIS

NECK AND SEARCHED HIM AND HIS BACKPACK BRIEFLY. ABOUT THIS TIME, THREE CARABINEROS, ACCOMPANIED BY A LOCAL RESIDENT, ARRIVED ON THE SCENE. THEY ASKED THE PATROL COMMANDER TO TURN WEISFEILER OVER TO THEM. THE COMMANDING LIEUTENANT REFUSED AND ORDERED THE CARABINEROS OUT OF THE AREA, APPARENTLY BERATING THEM FOR LETTING WEISFEILER GET PAST THEM AND ENTER A MILITARILY RESTRICTED ZONE.

9. AMONG THE CONTENTS OF WEISFEILER'S BACKPACK WERE AN "INFRA-RED NIGHT VIEWING DEVICE" (NFI), BINOCULARS, A BOWIE KNIFE, A DOCUMENT OR CARD INDICATING THE PERSON WAS A PROFESSOR AT AN AMERICAN UNIVERSITY, TWO PAIRS OF MOUNTAIN BOOTS, CLOTHES, TWO BOOKS, A SLEEPING BAG, TENT AND A DETAILED, COLORED FOLDING MAP OF THE AREA BETWEEN CHILLAN AND PARRAL, MOST LIKELY MADE IN THE UNITED STATE (COMMENT: THE SEARCH ITSELF WAS CONDUCTED BY THE PATROL COMMANDER AND A CNI MEMBER ATTACHED TO IT. OUR SOURCE WAS PRESENT, HOWEVER. HE WAS QUITE INSISTENT THAT WEISFEILER HAD BINOCULARS AS WELL AS THE "NIGHT VISION DEVICE." WEISFEILER WAS AT FIRST ASSUMED TO BE A RUSSIA SPY, EITHER FROM HIS NAME OR SOMETHING FOUND IN HIS

BACKPACK. LATER, WHEN HIS AMERICAN PASSPORT WAS FOUND INSIDE A DOUBLE FOLD OF HIS SLEEPING BAG, THE LIEUTENANT IN CHARGE OF THE PATROL ACCUSED HIM OF BEING A CIA SPY.

10. DELIVERY OF WEISFEILER TO THE COLONIA: THE PATROL THEN CROSSED THE NUBLE RIVER, MAKING USE OF A RUBBER BOAT KEPT AT A LOCAL'S HOUSE WHICH OVERLOOKS THE CABLEWAY CROSSING. WEISFEILER WAS TAKEN DOWNSTREAM ABOUT FIVE KILOMETERS AND THEN STRIPPED AND SEARCHED MORE THOROUGHLY. THE COMMANDER OF THE PATROL AGAIN ACCUSED WEISFEILER OF BEING A SPY AND BEGAN TO KICK HIM, STRIKE

HIM WITH HIS GUNBUTT, AND SUBMERGE HIS HEAD IN THE RIVER. AT THIS POINT, WEISFEILER BEGAN TO SHOUT HIS NAME, THE FIRST PART OF WHICH THE SOURCE SAID HAD TWO SYLLABLES ALONG THE LINES OF YURI OR BASIL AND ALSO BEGAN TO SHOUT TO CONTACT THE AMERICAN EMBASSY. DURING THE SECOND INTERVIEW, SOURCE DREW A MAP OF THE LOCATION OF THE INCIDENT WHOSE ORIENTATION AND FEATURES CORRESPOND TO THE LOS SAUCES-NUBLE RIVER AREA. IN THE THIRD INTERVIEW HE GAVE US THE NAMES OF THE TWO RIVERS INVOLVED, INDICATING THAT HE HAD CONSULTED A MAP TO REFRESH HIS MEMORY.

11. IN ACCORDANCE WITH THEIR STANDING ORDERS, THE PATROL THEN CROSSED TO THE NORTH SIDE OF THE NUBLE, AFTER HAVING RADIOED THEIR BASE CAMP INFORMING IT THAT THEY HAD TAKEN A PRISONER. AT A GUARD SHELTER ALONG THE SOUTHERN EDGE OF THE COLONIA THEY TURNED WEISFEILER OVER TO THE COLONIA'S CHIEF OF SECURITY. THIS INDIVIDUAL, ACCORDING TO THE SOURCE, WAS CALLED EITHER DOCTOR OR PROFESSOR AS A NICKNAME. AT THIS POINT, WEISFEILER BEGAN TO SHOUT QUOTE ASSASSINS, NAZIS AND I KNOW HE'S HERE END QUOTE. THE PATROL'S COMMANDER AND THE COLONIA'S SECURITY CHIEF ENTERED THE COLONIA AND INTERROGATED WEISFEILER FOR A PERIOD OF SOME TWO HOURS. WHEN THE INTERROGATION WAS OVER, THE PATROL'S COMMANDER EMERGED AND STATED THAT THE PRISONER WAS NEITHER A RUSSIAN NOR A CIA SPY, BUT A JEWISH SPY INTERFERING WITH THE ARRIVAL OF MR. SMITH. SOURCE AT THIS POINT REMARKED TO EMBOFFS THAT WITH THIS SEQUENCE OF IDENTIFICATIONS WEISFEILER COULD JUST AS PLAUSIBLY HAVE BEEN LABELED A CHINESE SPY, AND THAT HE DIDN'T SEE WHY A SIMPLE TOURIST SHOULD BE TREATED IN SUCH A MANNER. MOST OF WEISFEILER'S POSSESSIONS WERE SENT TO THE CNI'S HEADQUARTERS IN SANTIAGO, WHILE OTHERS WERE

OUR SOURCE STATED THAT THE COLONIA IS USED AS A HOLDING TANK FOR EXTREMISTS CAPTURED TRYING TO ENTER THE COUNTRY CLANDESTINELY AND THAT THESE PERSONS ARE LATER SHIPPED TO OTHER PARTS OF CHILE AND USED IN STAGED SHOOT-OUTS WITH THE SECURITY FORCES. HE OFFERED THE OPINION THAT THIS ORDER TO CLEAN OUT THE COLONIA WAS PROBABLY RELATED TO THE SERIES OF SANTIAGO CONFRONTATIONS WHICH OCCURRED IN MID-JUNE AND RESULTED IN THE DEATHS OF 12 PERSONS. ON JULY 14, THE CHARGE AND THE ACTING CHIEF OF THE CONSULAR SECTION MET WITH HANS SPOHN, THE CHARGE OF THE FEDERAL REPUBLIC OF GERMANY, TO DETERMINE IF HE HAD ANY INFORMATION ON THE COLONIA WHICH WOULD ENABLE US TO CONFIRM SOURCE'S STORY. A FORMER GERMAN AMBASSADOR PREVIOUSLY VISITED THE COLONIA AND THERE ARE SEVERAL GERMAN CITIZENS ATTEMPTING TO EXTRICATE RELATIVES FROM THE COLONIA. WHILE INTERESTED AND WILLING TO BE OF ASSISTANCE, THE CHARGE COULD ADD LITTLE TO THE KNOWLEDGE WE ALREADY HAD. SPECIFICALLY, THE GERMAN EMBASSY DOES NOT HAVE ANY ACCESS OR CONTACTS INSIDE THE COLONIA WHICH COULD BE USED TO CHECK OUR SOURCE'S INFORMATION, AND THE COLONIA HAS REBUFFED ALL THEIR ATTEMPTS TO TALK TO RESIDENTS.
