1. POST REQUESTS DEPARTMENT APPROVAL TO OBTAIN LEGAL SERVICES TO PERMIT CONSULAR OFFICERS TO PERFORM DUTIES RELATING TO PROTECTION OF U.S. NATIONALS.

2. FOLLOWING INFORMATION IS PROVIDED PER 2 FAM 283.4:

A. POST HAS BEEN PRESSING FOR SOME TIME FOR A THOROUGH INVESTIGATION INTO THE JANUARY 1985 DISAPPEARANCE OF U.S. CITIZEN BORIS WEISFEILER. WE NOW BELIEVE THAT WE CAN ASK TO REOPEN THE INVESTIGATION IN ORDER TO QUESTION THE MEMBERS OF THE ARMY PATROL ALLEGEDLY IN THE AREA AT THE TIME OF HIS DISAPPEARANCE. TO PRESS THE CASE AND TO FOLLOW CAREFULLY THE PROCEEDINGS, POST WILL NEED TO ENGAGE A KNOWLEDGEABLE LOCAL ATTORNEY.

B. SELECTED ATTORNEY IS ALFREDO ETCHEBERRY.

C. ALFREDO ETCHEBERRY IS A VERY PROMINENT LOCAL ATTORNEY WHO HAS HANDLED, AND IS NOW HANDLING, VERY SENSITIVE CASES ON BEHALF OF THE USG AND THE EMBASSY. HE IS VERY WELL KNOWN FOR THE EXCEPTIONAL SERVICE HE HAS PROVIDED TO THE EMBASSY IN THE PAST.
