K: Given the hypocrisy and paranoia of this place there are two things I want to mention. Somebody told me--they said that the reason I didn't come to the George Stevens. . . .

B: (Laughter)

K: I was working on the Law of the Sea speech and can't get away.

B: I work on the theory occasionally in our enlightened self-interest to have a good time together.

K: The real reason I am calling is I have been told and read in John Osborne you are of the view because I did not respond to you that evening at the movie premier I therefore don't object to Woodward and Bernstein. My view is this. This is for you and I would be glad to sit down with you and go over it. Their really major significant mistakes both as to sources and as to context and sometimes as to part that concerns me. On the other hand, for me to get in a debate with them in which I repeat charges I cannot then explain. They will get their source who are self-serving guys to repeat it. It is a useless exercise. Therefore, I have taken the position I talk to nobody. Not to Osborne.

I will say no more about that book. That silence should not be construed as approval. What I would like to do, when all the sales that can be serviced are serviced I would like to sit down with you and go over what they have done because I think it has some \_\_\_\_\_ of journalistic effort. We can do it in a month or two. It doesn't. . . they have put together something rather staggering.
